SUPPORTED LIVING SUPERVISOR

Linck Child, Youth & Family Supports ("Linck") requires a Supported Living Supervisor. This is a permanent, full-time (70 hour bi-weekly) position beginning as soon as possible.

The Supported Living Supervisor is responsible for coordination and supervision of a team who provide support to children and youth waiting for alternate care treatment or placement. They will coordinate the staffing and oversight of the Supported Living Program; monitor and consult with workers to ensure placement resources are available; and coordinate structure, safety and security geared to promoting positive growth and development for all children and youth. Volunteer Drive Coordination is also part of this leadership portfolio.

Qualifications:

- At minimum a Bachelor of Social Work, but a Master of Social Work degree is preferred and a minimum of three years experience as a social work practitioner in a child welfare agency.
- Preference will be given to candidates who have completed the Child Welfare Pathway to Authorization Series and/or are Authorized Workers.
- Expert knowledge of CYFSA legislation and legislation relating to foster care, and children in care; the needs and services required by children in care, and the different placement resources outside the foster care system.
- Vision to cultivate a comprehensive and responsive living arrangement for child and youth with intensive service needs.
- Strong collaboration and ability to engage with Community Partners.
- Clinical skill in therapeutic treatment and developing therapeutic environments.
- Knowledge of legal proceedings/terminology to liaise with legal counsel regarding children in care, resource homes, and adoption as required.
- Tact and diplomacy, excellent verbal and written communication skills, organizational skills, and interpersonal skills to liaise with Agency personnel, children in care, resource homes, other resources in the community and outside the Municipality, legal counsel, and other service-related groups.
- Preference will be given to persons with a strong understanding and extensive experience working with other cultures, heritages and traditions.
- A commitment to developing the highest quality culturally responsive service possible for the various communities that we serve.
- The ability to communicate in French is an asset.
- A valid driver's license and use of a reliable personal vehicle.
